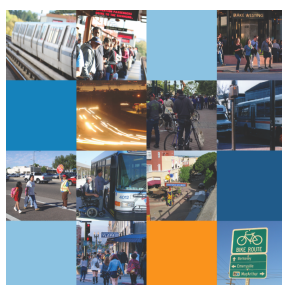

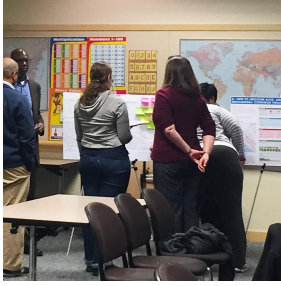
#### Alameda CTC Receives Over \$16 Million in Senate Bill 1 Funding for Projects and Programs
