# **EXECUTIVE DIRECTOR'S REPORT**

FEBRUARY 2020

The Executive Director's Report provides focused updates on Alameda CTC's work to improve transportation throughout Alameda County. This report provides status updates on key activities, including capital projects delivery and express lane operations; planning, policy and program implementation; finance and contracting; and programming and project controls. In addition, it contains brief summaries of advisory committee and agency activities.

This monthly update provides a synopsis of transportation project and program implementation funded with local, regional, state and federal funds.

# **Project Updates**

Interstate 580 Express Lanes celebrate 4th anniversary!



Since opening in February 2016, the Interstate 580 (I-580) Express
Lanes have been operating along approximately 10 miles from Hacienda Drive in Pleasanton to Greenville
Road in Livermore in the eastbound direction, and approximately 12 miles from Greenville Road to the I-580/
I-680 Interchange in Dublin in the westbound direction.

By optimizing corridor capacity, the express lanes have provided motorists with significant benefits, including travel time savings and travel reliability.


The express lanes are toll-free for carpools, clean-air vehicles, motorcycles and transit vehicles.

Drivers of single-occupancy vehicles can pay a toll to use the express lanes, which during peak times at congested locations have recorded 10-25 mph faster lane speeds and a better level of service than general purpose lanes.

From inception through December 2019, the I-580 Express Lanes have recorded over 31.5 million total trips, and revenues fund ongoing operations and facility maintenance.

# **Planning and Program Updates**

### **Student Transit Pass Program**

In 2016, Alameda CTC initiated the first year of a three-year Student Transit Pass Pilot Program (STPP). The pilot ended in July 2019. As a result of the effective implementation and evaluation of the STPP, in December 2018, the Alameda CTC approved continuation and expansion of the program for five years beyond the pilot period, including Phase 1 of the STPP for the 2019-20 school year.

A total of 62 schools in 11 school districts are currently participating in the Phase 1 expansion of the STPP during the 2019-20 school year.



The STPP includes all middle and high schools in most districts, and a subset of schools in Alameda Unified School District, Fremont Unified School District and Oakland Unified School District.

The program will add more schools and school districts in the 2020-21 school year.

### Safe Routes to Schools Program

The Alameda County Safe Routes to Schools (SR2S) Program is now in its 14th year of operations. The program team continues to work to meet program goals that the Commission adopted in January 2017. One of those goals calls for comprehensive evaluation of

the program. The first of these ongoing evaluation efforts was completed in January 2020. The evaluation report found strong participation in the program throughout the county with parents, school administrators and students viewing the program as an asset. The evaluation report also makes several recommendations to continue improving the program, such as more targeted outreach to under-resourced schools. # **Policy News**

## Alameda CTC's new Chair and Vice Chair

Alameda CTC unanimously elected its new Commission Chair and Vice Chair during the first Commission meeting of 2020—City of San Leandro Mayor Pauline Cutter and City of Emeryville Councilmember John Bauters, respectively.

Chair Cutter, a member of the Commission since 2012, and Vice Chair since 2018, said that she is pleased to be elected to serve as Chair of the Commission. "It is an honor to lead Alameda CTC in partnership with my colleagues, as we continue to drive forward transportation excellence with acclaimed projects and programs throughout Alameda County."

Chair Cutter outlined several priorities for 2020 and beyond that include::

- Advancement of high profile multi-jurisdictional, multimodal corridor improvements
- Improving transit options throughout the county to provide a reliable and connected system
- Ensuring safe mobility options for bicyclists and pedestrians
- Pushing forward rail safety improvements in partnership with other agencies, importantly the Countywide Rail Safety Enhancement Program
- Expansion of model educational and supportive programs like Safe Routes to Schools and the Affordable Student Transit Pass program
- Closing gaps in our trails network
- Expansion of express lanes

"Thanks to the voter-approved Measure BB, we are able to leverage those local dollars to support multimodal transportation infrastructure in Alameda County, including to improve mobility and safety for bicyclists and pedestrians, and enhance and support transit service, while also providing programs to our youth and seniors to make our county more livable and affordable" notes Vice Chair John Bauters.

# **Programming Updates**

# Transportation Fund for Clean Air Program, FY 2020-21

As the Transportation Fund for Clean Area (TFCA) County Program Manager for Alameda County, Alameda CTC is required to program approximately \$2.5 million in TFCA funds available from the Bay Area Air Quality Management District (Air District). Projects eligible for TFCA funding are to result in the reduction of motor vehicle emissions and achieve "surplus" emission reductions beyond what is currently required through regulations, ordinances, contracts or other legally binding obligations. Projects typically funded with TFCA include shuttles, bicycle lanes and lockers, transit signal priority, signal timing and travel demand management programs.

This month, the Commission will consider approving the FY 2020-21 TFCA Program Manager Fund Expenditure Plan, Policies and Call for Projects release schedule. A Call for Projects is tentatively scheduled for release in late spring. Alameda CTC will evaluate the proposed projects for TFCA eligibility and cost-effectiveness to determine a recommendation for the FY 2020-21 TFCA program by fall 2020.

# 2020 Comprehensive Investment Plan update

Alameda CTC's Comprehensive
Investment Plan (CIP) is a near-term
strategic programming document. It is
through this document that fund sources
administered by Alameda CTC are
consolidated and programmed through
a singular programming cycle. The 2020
CIP, approved by the Commission in
June 2019, will be updated this spring
to reflect technical adjustments and offcycle programming.

# **Finance Updates**

# Alameda CTC retains a strong financial position

During January, the finance team prepared the fiscal year (FY) 2019-20 second quarter financial report for presentation to the Finance and Administration Committee (FAC) and the Commission for approval in February. The second quarter financial report includes agency revenues and expenditures through December 31, 2019 compared to year-to-date budget. Alameda CTC's expenditures through the second quarter are within year-to-date budget authority, and the agency remains in a strong financial position.

In addition, the finance team prepared the FY 2019-20 second auarter investment report for presentation to the FAC and the Commission for approval in February. The second quarter investment report includes cash and investment balances compared to prior year-end balances segregated by portfolio, along with a portfolio review for the quarter prepared by Alameda CTC's investment advisors, Public Trust Advisors, and a report of all holdings in the portfolio. Alameda CTC's investments through the second quarter are in compliance with its investment policy, and the Agency has sufficient cash flow to meet expenditure requirements.




#### **Measure BB Program Distributions**

Measure BB direct local distributions began in April 2015 and total over \$353.3 million; over \$6.8 million was distributed in November 2019.




#### **Measure B Program Distributions**

Measure B direct local distributions have totaled more than \$1.1 billion since 2002. In November 2019, over \$7.0 million was distributed for four programs.



#### **Vehicle Registration Fee**

Since 2011, Alameda CTC has distributed more than \$61.4 million for local road repair; over \$900 thousand was collected in November 2019.

## **Golden Sneaker Contest Now Underway**

The 2020 Golden Sneaker Contest kicked off on February 24 and runs through March 6, 2020. The two-week competition encourages students, parents, teachers and administrators to walk or roll to school, which is healthy for them, or opt for carpooling or taking transit, which is healthy for the environment. The contest encourages teamwork by having classrooms compete against each other.

Every day of the competition, teachers in each classroom track the number of students who walk, roll, carpool or take transit to school. At the end of the competition, the classroom at each participating school with the highest percentage of students using active or shared modes receives a Golden Sneaker trophy. The trophies are made from sneaker shoes donated by the Golden State Warriors! Additionally, the students of each winning classroom receive a pair of shiny golden shoe laces.

## **Committee Activities**

## February advisory committees

In February, the following committees met. Highlights include:

- February 6 The Alameda County **Technical Advisory Committee** (ACTAC) approved the Transportation Fund for Clean Air FY 2020-21 Expenditure Plan Application and Call for Projects. The committee also received information on implementation of Senate Bill 743 requirements in Alameda County and updates on the 2021 Transportation Improvement Program and Alameda County federal inactive projects.
- February 13 The Bicycle and <u>Pedestrian Advisory Committee</u> (BPAC) received updates on the California Department of Transportation, District 4 Pedestrian Plan and Alameda County's Safe Routes to Schools Program. Additionally, the committee received information on the 2020 Countywide Transportation Plan: Needs Assessment for Active Transportation and on the 2019 Performance Report.
- February 24 The joint **Paratransit Advisory and Planning Committee** (PAPCO) and Paratransit Technical Advisory Committee (ParaTAC) met to host a panel discussion on the state of emerging mobility in Alameda County, with a focus on the use of Transportation Network Companies (TNCs) by people with disabilities and best practices around contracting with TNCs.

The award recognizes cities that are leading the way in prioritizing children's safety while also improving pedestrian and bicyclist safety for all ages through Vision Zero. The City of Fremont has reduced major crashes among youth by more than 90 percent.
