

NOTICE OF INTENT TO ADOPT A NEGATIVE DECLARATION Announcement of Public Hearing for changes proposed for Interstate 80 (I-80)/Interstate 580 (I-580)/Interstate 880 (I-880)

WHAT'S BEING PLANNED

The California Department of Transportation (CALTRANS) is proposing to partially lower, raise, replace, or reconstruct connectors in the MacArthur Maze at either Interstate 80 (I-80), Interstate 580 (I-580), or Interstate 880 (I-880) to increase vertical clearance for freight vehicles in the City of Oakland, in Alameda County.



WHY THIS AD

CALTRANS has studied the effects this project may have on the environment. Our studies show it will not significantly affect the quality of the environment. The report that explains why is called an Initial Study/Environmental Assessment (IS/EA). This notice is to tell you of the preparation of the IS/EA and of its availability for you to read. An open forum hearing will be held to give you an opportunity to talk

about certain design features of the project with CALTRANS' staff before the final design is selected.
