**Subject:** Approval of Consultant Shortlist and Authorization to Interview

#### **Recommendations:**

Staff recommends that the Commission approve the shortlist of four firms to be interviewed in response to Alameda CTC Request for Proposals for Public Opinion Research Services for Development of a Transportation Expenditure Plan (Alameda CTC RFP No. A10-0007).

#### **Summary**

Public opinion research services are required to support the development of a new Transportation Expenditure Plan for Alameda County's half-cent transportation sales tax measure that may be placed on the November 2012 ballot. The Alameda CTC released a request for proposals on December 8, 2010, for public opinion research services. On December 20, 2010, the Alameda CTC held a pre-bid meeting and provided information on the requested services. A total of 8 firms attended the pre bid meeting. Proposals were due on January 7, 2011. The following four teams submitted proposals:

- Valerie Brock Consulting
- EMC Research
- Fairbank, Maslin, Maullin Metz & Associates
- Quantum Market Resarch, Inc.

A Consultant Selection Panel comprised of representatives from ACTIA's Contract Equity Consultant firm (L. Luster and Associates), ACTIA's Project Controls Team, and Commission staff completed the review and evaluation of the proposals. Based on the evaluation of the proposals, the Consultant Selection Panel is recommending that the interview shortlist include all four firms. Consultant selection will be based on a combination of proposal and interview criteria scoring. The proposed actions would approve an interview shortlist of four teams.
